

Gold Club Subscription Agreement

I, **[FullName]** (hereafter referred to as 'Subscriber'), enter into this Gold Club Subscription Agreement (hereafter referred to as "Agreement") on **[Date]**. This agreement provides for a Gold Club Subscription (hereafter referred to as 'Subscription') offered by **[BusinessName]**, located at 220 Park Place, Suite 300, Covington, LA 70433. This Agreement does not negate any other existing agreement(s) between **[FullName]** and **[BusinessName]**.

Gold Subscription Term:

This Subscription is for a term of 6 months, beginning on **[StartDate]** and ending on **[Expiration]**. This Subscription will Auto-Renew after expiration for another 6-month term, unless cancelled by the Subscriber. A cancellation notice must be received at least 15 days prior to the Subscription expiration. **[BusinessName]** reserves the right to terminate this Agreement for any violation of the terms, rules, or policies, or for non-payment of fees.

Gold Subscriber Dues:

The Gold Club Subscription, provided by **[BusinessName]**, is available for \$99 per 6-month term. Payment is made at the time of sale. A valid credit card must be retained on file for automatic renewal payments. If the credit card on file expires, the new expiration date must be provided, or a new valid credit card provided for automatic renewal payments.

Gold Subscriber Benefits:

As part of this Gold Subscription, the Subscriber will receive the following benefits:

- Unlimited Light System (TLS) sessions may be purchased at a discount of 40% off the regular session price. Daytime sessions would be \$30/hour. Overnight sessions would be \$240.
- A complimentary guest pass each month to bring one person, one time, who has never been to the Healthy Body Healthy Soul Light System, for up to 4 hours.
- Complimentary Detox Salt Bath each month.

Gold Subscriber Requirements:

- Subscribers must purchase **at least 8 hours** of Light System sessions **per month** during the term of the Subscription. These hours are sold at the 40% discounted rate (i.e., \$30/hour). To ensure this requirement is met each month, an 8-hour Light System Session Pass, (hereafter referred to as Session Pass), must be purchased. The cost of this Session Pass is \$240 (i.e., 8 hours * \$30/hour). During the term of the Subscription, the initial Session Pass will be purchased simultaneously with the Club Subscription. This Session Pass will expire one month after the sale date. The Session Pass will then Auto-Renew after expiration each month during the 6-month term of the Subscription. Any unused hours from the Session Pass will not rollover to the next month. They will expire unused. Overnight session hours cannot be used to fulfill this requirement.
- Subscribers may attend an overnight session at the 40% discounted rate (i.e., \$240).
- Subscribers receive 1 complimentary Detox Salt Bath per month. Any unclaimed Detox Salt Bath will not rollover to the next month.

- These discounted rates for Subscribers cannot be combined with any other discount. The exception is a Subscriber who is a Veteran can still receive their free 4 hours of The Light System time each month.
- The Subscription can be transferred to another person once. Members to whom a Subscription is transferred must also sign a contract.
- The Subscription cannot be shared.
- All other existing policies, procedures and guidelines at Healthy Body Healthy Soul remain in effect.
- Members who renew their Gold Club Subscription Contract, after the 6-month term expires, will receive a complimentary overnight session.
